The paper still needs professional proofreading as I could not understand most of the arguments presented. Hence, the author/s need/s to pass the manuscript to a professional proof reader to improve the quality of the paper.

Other comments:

- Remove reference to Wikipedia (p.7) and elsewhere and replace it with better source.

- Page 7, what do SA and LAF mean? I requested this in my previous review - The paper should have clearly spelled out the abbreviations of SA and LAF to bring out their similarities and differentiation in thinking on tax/zakat payments. This also applies to other abbreviations need to be written in full in the first time and then use the abbreviation.

- Page 10, change 'God' to 'Allah'

Thanks for improving the paper. It looks much better but there are four minor issues:

1. The abstract needs rewriting. For example, I cannot understand the purpose and the Design/methodology/approach.
2. In the Findings, could you please show how 'tabayyun' was utilised or helped to generate the findings.
3. Before section 'RESEARCH METHODOLOGY' on p.7, you need to summarise the findings and also to go over what is coming next, i.e. The remainder of the paper is organized as follows. The following section presents the research

methodology. The subsequent section discusses the research results and the final section concludes by summarising the results and offering recommendations for future research.

4. The implications for the upon future research, the practice and society need to be made clearer in the paper. These can be dealt with in the conclusion section.
