Tujuan dalam penelitian ini adalah untuk mengetahui pengaruh kinerja keuangan yang diukur dari *Return on Asset* (ROA), *Return on Equity* (ROE), *Earning per Share* (EPS), *Price Earning Ratio* (PER) terhadap harga saham pada perusahaan semen yang terdaftar di BEI, dan untuk mengetahui pengaruh kinerja keuangan yang diukur dari ROA, ROE, EPS, dan PER yang berpengaruh dominan terhadap harga saham pada perusahaan Semen yang terdaftar di Bursa Efek Indonesia. Dalam penelitian ini menggunakan analisis kuantitatif untuk melakukan pengolahan data berupa laporan keuangan yang masih berbentuk angka-angka dengan menggunakan rasio keuangan. Populasi dari penelitian ini adalah perusahaan semen yang *go public* di Bursa Efek Indonesia, dengan menggunakan laporan keuangan perusahaan tahun 2010-2014. Model analisis ini menggunakan persamaan regresi linier berganda.

Hasil pada penelitian ini menunjukkan bahwa variabel *Return on Asset* (ROA), *Return on Equity* (ROE), *Earning Per Share* (EPS), dan *Price Earning Ratio* (PER) berpengaruh signifikan secara parsial terhadap harga saham. Hasil penelitian uji R Square menunjukkan hubungan antara variabel *Return on Asset* (ROA), *Return on Equity* (ROE), *Earning Per Share* (EPS), dan *Price Earning Ratio* (PER) mempunyai hubungan yang sangat kuat. Sedangkan hasil penelitian uji r^2 menunjukkan variabel *Earning Per Share* (EPS) berpengaruh dominan diantara variabel yang lain.

ABSTRACT

This research is meant to find out the influence of financial performance which is measured by using Return on Asset (ROA), Return on Equity (ROE), Earning per Share (EPS), Price Earnings Ratio (PER) to the stock price of cement companies which are listed in the IDX, and to find out the influence of financial performance which is measured by ROA, ROE, EPS, and PER which have dominant influence to the stock price in the cement companies which are listed in Indonesia Stock Exchange. This research applies quantitative analysis in order to manage the data in the form of financial statement which is in the form of figures with the use of financial ratio. The population is the cement companies which have gone public in Indonesia Stock Exchange and the financial statement of the company in 2010-2014. The analysis model has been done by using multiple linear regressions.

The result of this research shows that partially the variables i.e. Return on Asset (ROA), Return on Equity (ROE), Earning Per Share (EPS), and Price Earnings Ratio (PER) have significant influence to the stock price. The result of R Square test shows that the correlation among the variable i.e. Return on Asset (ROA), Return on Equity (ROE), Earning Per Share (EPS), and Price Earnings Ratio (PER) is firm. Meanwhile the result of r^2 test shows that the variable of Earning per Share (EPS) has dominant influence among other variables.
