

ABSTRAK

Penelitian bertujuan untuk menguji pengaruh Kinerja Keuangan Khususnya; Derajat Desentralisasi Fiskal, Rasio Kemandirian Keuangan Pemerintah Daerah, dan Ratii Efektivitas Pendapatan Asli Daerah (PAD) terhadap Indeks Pembangunan Manusia (IPM).

Populasi yang digunakan dalam penelitian ini adalah 38 Kabupaten/Kota di Provinsi Jawa Timur yang terdiri dari 29 Kabupaten dan 9 Kota periode 2016-2018. Berdasarkan populasi diatas maka sampel yang digunakan dalam penelitian ini adalah Data Laporan Realisasi Anggaran (LRA) dan Data Indeks Pembangunan Manusia (IPM) pada Kabupaten/Kota di Provinsi Jawa Timur. Teknik pengambilan sampel menggunakan metode *purposive sampling*. Data dalam penelitian menggunakan data sekunder. Adapun teknik analisis data yang digunakan adalah analisis regresi linier berganda dengan alat bantu aplikasi SPSS (*Statistical Product and Service Solution*) versi 22,0.

Hasil Penelitian menunjukkan bahwa variabel Derajat Desentralisasi berpengaruh signifikan terhadap Indeks Pembangunan Manusia. Sedangkan Rasio Kemandirian Keuangan Pemerintah Daerah saling berhubungan tapi tidak berpengaruh signifikan. Sementara, Rasio Efektivitas PAD tidak berhubungan berpengaruh signifikan terhadap Indeks Pembangunan Manusia.

ABSTRACT
